#### **CURRENT PORTFOLIO POSITIONING**

The North Square Tactical Growth Fund entered the second quarter with a moderately conservative portfolio. The Fund's allocation was 64% U.S. equity, 11.5% International equity, 7% fixed income, and 17.5% cash. The U.S. equity allocation was split between growth and value and our fixed income exposure was in Inflation Protected U.S. Treasuries. Our diversification worked well in early April but even the value holdings were hit by month's end. We lowered our equity exposure by selling our small cap value and Brazil ETFs and invested the

proceeds in money market securities on April 22nd and 28th. We're starting May conservatively with the following portfolio weightings: 57.5% U.S. equity, 6.1% International, 7.7% Fixed Income, and 28.7% cash. We will continue in our efforts to build a diversified portfolio using our Sharpe ratio research process, which is conducted daily on almost 2,000 ETFs. Sharpe ratio, developed by Nobel Laureate William F. Sharpe, is an industry standard for measuring the risk-adjusted return of a portfolio.
