



### **CURRENT PORTFOLIO POSITIONING**

We believe the North Square Tactical Growth Fund's portfolio allocation remained conservative for the month of May. We started the month with 57.5% U.S. equity, 6% International, 7.7% Fixed Income, and 28.7% cash. Continued volatility and negative price action in equity and fixed income markets had us trim our Nasdaq 100 holdings on May 5th. We finished the remainder of May without making any further moves and our

Value and International positions all had positive returns for May. We are starting June with close to one-third of the Fund in cash. The full allocation is 54.3% U.S. equity, 6.2% International equity, 7.8% Fixed-Income, and 31.7% cash. We're working to try to add investments to the Fund that are compensating for the high levels of volatility the markets are now experiencing and meet our diversification goals.
