



CURRENT PORTFOLIO POSITIONING

The North Square Tactical Growth Fund finished 2022 with what we consider to be a moderately conservative portfolio allocation. The Fund started the month with approximately 65% U.S. equity ETFs and 35% money market securities. On December 14th we added to our existing Value position and moved a small position out of Regional Banks and into

Aerospace and Defense. We ended December 31, 2022, with a 69.5% U.S. equity position and 30.5% in money market securities. We are following our Sharpe ratio-based model closely and hope to move to a more invested posture in 2023.

The Sharpe Ratio was developed by Nobel laureate William F. Sharpe and is used to help investors understand the return of an investment compared to its risk. The ratio is the average return earned in excess of the risk-free rate per unit of volatility or total risk.

A correlation of 1 means the two asset classes move exactly in line with each other, while a correlation of -1 means they move in the exact opposite direction.
