



CURRENT PORTFOLIO POSITIONING

The North Square Tactical Growth Fund entered August nearly fully invested. We made no changes during the month and the Fund's portfolio's allocation heading into September remains: 84% equities, 13% fixed-income, and 3% cash. International holdings still make up approximately one-third of the Fund's holdings. Our equity positions in Europe, Mexico, and Japan combine to total 19.32% of the portfolio and all our fixed-income exposure is international. We will continue to monitor our holdings and the markets closely and will try to stay invested in the sectors that we believe compensate investors best for their potential risk.
