## **CURRENT PORTFOLIO POSITIONING**

The North Square Tactical Growth Fund finished the third quarter fully invested. The Fund is starting October with 80.8% in domestic equity, 5.1% in international equity, 10.0% in US Treasury Bonds, 2.0% in precious metals, and 2.1% in money market securities. Our only trade during the month of September was the purchase of a precious metals mining ETF. The portfolio continues to own a balance of growth and value, as well as a few concentrated sector positions [healthcare,

financial services] in its equity holdings. The international equity position is in an ETF which owns Eurozone stocks. Our position in U.S. Government Treasuries is being watched closely due to the recent interest rate cuts and the reaction in the yield curve. We will continue to look for opportunities in the ETF universe which we believe will compensate investors strongly for risk.

The Sharpe Ratio was developed by Nobel laureate William F. Sharpe and is used to help investors understand the return of an investment compared to its risk. The ratio is the average return earned in excess of the risk-free rate per unit of volatility or total risk.

Correlation is a measure of how investments move in relation to one another. A correlation of 1 means the two asset classes move exactly in line with each other, while a correlation of -1 means they move in the exact opposite direction. A correlation of zero means that the returns are completely uncorrelated, or a "non-correlated" asset.
