

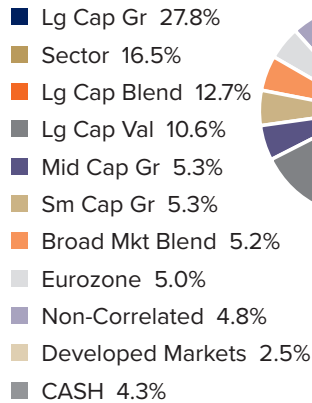

CURRENT PORTFOLIO POSITIONING

The North Square Tactical Growth Fund made two minor changes to its allocation in February. We started the month with 86.8% in equities, 5% in fixed income, and 8.2% in cash. Early in the month we added a 2.5% position in an international growth ETF and moved 5% from our value ETF to a new position in a semiconductor ETF. These moves, along with market movement and fund flows, brought our cash position down to 4.34% at the month's end. Our domestic equity exposure totals

We also own sector specific ETFs representing financials, biotechnology, and the earlier mentioned semiconductors. Our international allocation in Eurozone and large growth totals 7.51%. We are watching our holdings for weakness and our model for any ETFs that we believe offer diversification and better compensation with lower risk.
